

## Note for authors

The articles should be prepared in accordance with the requirements for the structure of scientific papers, including the purpose and the object of the study, the discussion and evaluation of the researched issue's historiography, the sources for the study and the conclusions. A short annotation in the language of the article and keywords should be given before the main text with an English translation.

A list of sources and literature is given at the end of the article in accordance with the citation examples given below. The entries should be arranged alphabetically; if the article is in Latin script, the citations in Latin script should precede those in Cyrillic script; if the article is in Cyrillic script, *visa versa*. Bibliographic citations in the text should be given in brackets, the number of a citation should be followed by a comma and cited page numbers.

### Requirements for formatting bibliographic citations

#### Formatting monograph citations

Author (Surname, Name). *Title*: subtitle [Other statements of responsibility: compilers, editors, translators etc.].<sup>1</sup> Edition (if given in the publication). Place of publishing: Publisher, year of publishing. Total number of pages (total number of volumes – if multivolume set). ISBN. (Main title of the series; series numeration)<sup>2</sup>.

Examples:

### Description for a part of a multivolume publication

Author (Surname, Name). *Title*: subtitle. Part number, *Part title*. [Other statements of responsibility: compilers, editors, translators etc.]<sup>3</sup>. Edition (if given in the publication). Place of publishing: Publisher, year of publishing. Total number of pages. (Main title of the series; series numeration)<sup>4</sup>.

Examples:

Kondratas, Benjaminas. *Kūrėjų pėdsakais*. Kn. 7, *Pagėgių kraštas*. Vilnius: Karminas, 2011. 312 p.

*Lietuvos dailininkų žodynas*. T. 2, 1795–1918. [Sudarė Jolanta Širkaitė]. Vilnius: Kultūros tyrimų institutas, 2012. 519 p.

### Citations

1) Articles in periodicals:

Author (Surname, Name). Article title: subtitle. *Publication title*, year of publishing, no. (vol., etc.), page numbers.

Example: Pritchard, Alan. Statistical bibliography and bibliometrics. *Journal of documentation*, 1969, vol. 25, no. 4, p. 348–349.

Note: if a number (volume) of a series has title, the latter is given in italics after the number, separated from the number by a comma.

Example: Paknys, Mindaugas. Fundatorių Pacų sarkofagai Pažaislyje. *Acta Academiae artium Vilnensis*, 2011, t. 60, *Dangiškieji globėjai, žemiškieji mecenatai*, p. 75–82.

2) Articles in monographs:

Author (Surname, Name). Article title: subtitle. In: Author (Surname, Name). *Title*: subtitle. Edition (if given in the publication). Place of publishing: Publisher, year of publishing, page number(s).

Examples:

Vladimirovas, Levas. 400 metų kultūros, švietimo ir mokslo tarnyboje. In: Vladimirovas, Levas. *Apie knygas ir bibliotekas*: straipsnių rinkinys. Vilnius: VU I-kla, 2002, p. 47–112.

Tazbir, Janusz. Skarga Piotr. In: *Polski słownik biograficzny*. Warszawa; Kraków: Polska Akademia Nauk. Instytut Historii im. Tadeusza Manteuffla, 1997, t. 38/1, z. 156, p. 35–43.

3) An article in a multi-volume publication:

Author (Surname, Name). Article title: subtitle. In: Author (Surname, Name). *Title*: subtitle. Part number, *Part title*. Edition (if given in the publication). Place of publishing: Publisher, year of publishing, page number(s).

Examples:

Bitinienė, Aurelija. Norberto Vėliaus vieta tautinio atgimimo sąjūdyje. In: *Laukuva*. D. 1. Vilnius: Versmė, 2005, p. 546–557.

Žukienė, Rasa. Mikalojaus Vorobjovo vaidmuo čiurlionistikoje. In: *Dailės istorikas ir kritikas Mikalojus Vorobjovas (1903–1954)*. T. 2, *Ižodinto vaizdo meistras*. Vilnius: R. Paknio leidykla, 2017, p. 83–118.

4) Electronic resource citations are given in accordance with the examples above, indicating the medium type in square brackets [interactive], access date and URL.

Examples:

Rehn, Catharina; Kronman, Ulf. *Bibliometric handbook for Karolinska Institutet* [interactive] [accessed date May 5, 2011]. 5) Archival document citations are formatted similar to the above, adding the place of holding and the document code.
